I am happy to announce that our proposed bylaws changes were adopted during our September 14 membership meeting. A summary of the bylaws changes are available for review on the <u>DCDS website</u>. Moving forward, all elections will be conducted by electronic ballot, making our society more inclusive and democratic. Members may request a paper ballot if that is their preferred method of voting. We will host the Annual Awards Meeting in January, when our newly elected officers and board members will be installed. I hope you will join us for that festive event.

During the Board of Directors meeting held on September 19, we heard a presentation from Kate Bouwkamp of the DC Office of Victim Services and Justice Grants on the Address Confidentiality Program (ACP). The program is designed to support and protect victims of domestic violence. Dentists and dental team members often see our patients more frequently than any other healthcare provider. Given that dental appointments generally are conducted without a spouse, partner or other family member present, we are in a unique position to assist those who are victims of abuse. Also during the meeting, the board voted on final appointments to the Strategic Plan Committee and will hold a meeting following the ADA House of Delegates (HOD) meeting that will take place later this month.

There are many resolutions to be discussed at the HOD meeting. We are very fortunate to have a great delegation representing our members: Drs. Katie Clark and Angela Noguera who serve as delegates, Drs. Pat Grogan and Clare McGorry who serve as alternate delegates. Also participating as a member of the delegation will be DCDS Secretary Dr. Sally Cram and our executive director, Kurt Gallagher. The team has worked hard to read and understand all of the resolutions that will be considered at the HOD meeting. I have learned so much from the meetings over the past year, from participation at the House of Delegates meeting in Texas in 2022 to attending the 4th District Annual Pre-Caucus in late September. We have exceptional representatives, and I am looking forward to participating with our delegates at SmileCon and the HOD meeting in Orlando. Of interest to watch for at the ADA House of Delegates meeting are the outcomes of many topics including resolutions on education, interstate licensing, incorporation of dentists who work for DSOs as members, as well as how to define underserved areas with respect to access to dental care. We will update the membership on outcomes from the ADA meeting.

The DCDS Board voted to add several new members to our committees now that the bylaws amendment was approved by the membership that grants flexibility with respect to committees. Thank you to those who volunteered and to those who have dedicated their time to our committees over the past year. If you are interested in serving on a committee, please contact the DCDS office.

We continue to advocate for our members and represent the concerns of members before DC Health and the DC Board of Dentistry. Our lobbying team, Mr. Brett Greene and executive director, Mr. Kurt Gallagher, led an effort to expand the scope of practice for dental assistants. The Board of Dentistry accepted our recommendation to authorize dental assistants to perform a number of advanced functions: coronal polishing, placement of pit/fissure sealants, and conducting glucose testing. The Board of Dentistry voted to advance the proposed regulations to implement these changes at its September meeting. We are awaiting publication of the final regulations, which will establish the new category of a Level III Dental Assistant authorized to perform the expanded functions.

As published in our last newsletter, we received clarification from the Board of Dentistry about new mandates for criminal background checks. Fingerprinting (by traditional ink and paper method or digital scan) will not be required for dental license renewal. In addition, during its September meeting, the Board of Dentistry adopted a policy to allow unregistered dental assistants who have been working in DC to register with greatly reduced financial penalties imposed. We are aware of several cases over the past year where dental assistants who worked in DC without first registering with the Board of Dentistry were fined up to \$5,000 and the dental practice was fined up to \$30,000. The Board's Policy on Incentivized Time Period for Registration of Dental Assistants is a way for unregistered dental assistants to come into compliance with DC requirements at greatly reduced penalties: \$250 paid by the dental assistant and \$500 assessed on the dentist or dental practice for each unregistered dental assistant. To receive these reduced penalties, the applicant must submit this cover letter with their registration application.

DC Board of Dentistry Updates

DC Board of Dentistry Adopts Policy for Greatly Reduced Financial Penalties When Unregistered Dental Assistants Come Forward to Register Through 12/31/2023

All dental assistants who work in DC are required to register with the Board of Dentistry. Over the past year the Board of Dentistry imposed fines on dental practices and dental assistants when it learned of unregistered dental assistants working in DC. Fines can range as high at \$5,000 on each dental assistant and \$30,000 on the dentist/dental practice.

DCDS is your advocate. We called upon the Board of Dentistry to suspend penalties to allow unregistered dental assistants to come forward to register with the Board. We also called for an end to the registration requirement for Level I dental assistants, but that proposal has not been accepted.

Recently the Board of Dentistry adopted the <u>Policy on Incentivized Time Period for Registration of Dental Assistants</u> to allow unregistered dental assistants who have been working in DC to register with greatly reduced financial penalties assessed.

- The policy will remain in effect until 12/31/2023.
- The <u>Incentivized Dental Assistant Registration Cover Letter</u> ("Cover Letter") must accompany a registration application in order to be covered by this policy.
- The penalty imposed on each dental assistant will be \$250 when they apply.
- The penalty for supervising dentists/dental practices will be \$500 per unregistered dental assistant.
- Dental assistants and dentists covered by this policy will be required to complete 2 continuing education hours in ethics.
- The Cover Letter includes the disclaimer that it "cannot be used against me for any other purpose," which provides the unregistered dental assistant and dentist/dental practice with protection from higher fines related to the employment of an unregistered dental assistant.

Dental Assistant Incentivized Registration Application Cover Letter

Unregistered dental assistants should apply to register with the Board of Dentistry through the <u>DC Health Licensing Portal</u>. If this is the first time they attempt to register, dental assistants will be eligible to submit the <u>90 Day Supervised Practice Form</u> that allows them to practice for 90 days, upon approval by the Board of Dentistry, while the application is under review.

Cover Letter acknowledgement (emphasis added)

I acknowledge and understand that as a result of the Applicant's unregistered dental assisting practice in the District of Columbia, the Applicant and Supervisory Dentist/Practice Owner will be subject to a monetary assessment of \$250.00 for the Applicant and \$500.00 for the Supervisory Dentist/Practice Owner and required to complete (2) continuing education credit hours in ethics, but this cover letter cannot be used against me for any other purpose. I acknowledge and understand that the benefits and protections of this cover letter shall only apply to applications submitted with this completed cover letter between September 20, 2023 and December 31, 2023. Failure to provide correct and complete information on this cover letter may result in additional penalties.

Advancement of Proposed Regulations for Dental Assistants

The Board of Dentistry voted to advance the proposed rule that authorizes advanced functions for the newly created Level III Dental Assistant:

- Coronal polishing
- Placement of pit/fissure sealants
- Performance of glucose testing
- While the Board declined to accepted the changes to the proposed regulations we recommended in our comments submitted earlier this summer, this action does advance implementation of the expanded functions.
- DCDS will provide notification when the final rule is published.
- Board staff did indicate that one of our recommendations may be taken up for consideration after the related update to DC law is passed (expected later this year).

2023 License/Registration Renewals


2023 is a license/registration renewal year. All applications to renew a license or registration to practice dentistry in DC must be submitted through the DC Health Licensing Portal. The portal will begin accepting renewal applications from dentists, dental hygienists and dental assistants in October. A specific date has not yet been announced. Dental professionals should receive notification by email from DC Health when the portal opens for renewal applications, and the DC Dental Society will send out a supplemental notification.

DC Health strongly encourages all users to review the instructions prior to beginning the process. License renewal applications must be submitted by December 31, 2023.

Board of Dentistry Clarifies Criminal Background Requirement

A criminal background check (CBC) will be required for license/registration renewal submissions in 2023 (fee of \$50). The Board of Dentistry recently clarified that the requirement will be dependent upon the type of application submitted. The table below summarizes how the requirement will be implemented.

Application Type	Method of Criminal Background Check
Renewal	Name search—include the applicant's gender, Social Security number, date of birth, and mailing address No fingerprint required.
New License/ Registration	Fingerprint Fingerprint may be taken by traditional roll method or live/electronic scan.
Reinstatement/ Reactivation	Fingerprint Fingerprint may be taken by traditional roll method or live/electronic scan.

Courses Required for DC License Renewal

The table below lists the continuing education requirements for 2023 license/registration renewal. DCDS offers the required courses as recordings from the 2023 Spring Symposium for Licensure.

These courses were held virtually. The Board of Dentistry now allows all CE requirements to be satisfied through online courses. Additional details regarding DC continuing education requirements for dentists, dental hygienists and dental assistants are available on the DCDS DC Licensure web page.



DCDS Members Pass Bylaws Amendment

During the September 14 monthly meeting, DCDS members voted to approve the proposed bylaws amendments.

The changes in the updated bylaws include:

- Affirming the right of members to participate in elections via electronic ballot, including votes on future bylaws amendments.
- Granting the board of directors the flexibility to establish new committees, or disband them, to enable an agile organizational structure that can better meet member needs.
- Specifying that elected officers and board members will be announced at the last meeting of the fiscal year. Officers shall assume the responsibilities of their respective offices on January 1st of the following year.
- Affirming that the membership may conduct business via an electronic meeting.
- Specifying that the Annual Awards Meeting will be held as the first meeting of the year.

ADA Terminates Relationship with Liquidation Company Following Complaints

The ADA is no longer accepting advertising from or conducting any business with liquidation company Overstocker after receiving multiple complaints from dentists alleging unfulfilled orders, unauthorized credit card transactions and limited or no customer assistance from the company.

The Association is advising members not to place further orders with Overstocker. Members who have already ordered products from the company should immediately contact their credit card companies to dispute charges if they have not received orders or notice unauthorized charges.



About the Program

The District's Address Confidentiality Program (ACP), administered by the Office of Victim Services and Justice Grants (OVSJG), helps people at risk of harm stay safe by shielding their street address from public records. ACP services are intended as one tool in an individual's broader safety plan.

This free program provides participants with:

- A legal substitute address to protect their home, work, or school address
- A confidential mail-forwarding service.



Who Is It For?

You may qualify for the ACP if you:

- (1) fear for your safety;
- (2) currently (or will soon) reside in the District of Columbia; AND
- Have experienced domestic violence, sexual assault, stalking, or human trafficking;
 - Are employed by an organization whose primary purpose is serving victims who have experienced the above offenses; OR
 - Are employed by an organization that focuses on reproductive healthcare.

Applicants are also required to: have moved within the past 60 days, be planning to move within the next 30 days, or have taken adequate measures to ensure their current address is not easily accessible online or through public records. Both adults and children may qualify.



How to Apply

Application assistants are available in several agencies across the District to answer questions, verify eligibility, and accept applications. They also can provide advocacy services and help you develop a comprehensive safety plan based on your individual needs.

How Does the ACP Work?

Substitute Address

Applicants who qualify receive an ACP **authorization card** with a substitute address. This card can be presented to any DC agency in place of your real home, work, or school address. Authorization cards are initially valid for 3 years.

With this legal substitute address you can interact with DC agencies without fear of your actual address appearing in public records. With a substitute address you can:

- Get a DC driver's license or ID card
- Enroll children in DC public/charter school
- Vote and sign petitions

While only District agencies are required to honor the substitute address, placing it on a DC driver's license or ID card will protect your actual address in many day-to-day situations.

Mail Forwarding

When first-class, certified, or registered mail is received at the substitute address, it is forwarded to your home address.

Limitations

A substitute address does not guarantee your actual address will not be required by other non-government agencies. Your real address will still be required for certain activities, including:

- Purchasing a home or property. (Note that the address may appear in related public listings.)
- Applying for a line of credit on your home.
- Setting up utilities for your home.

Additionally, the ACP does not forward junk mail, packages, or magazines; an advocate or application assistant can help you plan for safely receiving that mail. Other limitations may also apply.


