## Letter From the President

The ADA has selected DCDS as the 2014 national kickoff site for Give Kids a Smile Day (GKSD). GKSD will be held Friday, February 7, 2014. Under the leadership of Dr. Sally Cram, our Foundation continues to raise oral health awareness. Once again, DCDS will participate at the NBC4 Health and Fitness Expo in January providing screenings and education to at-need city residents. Through volunteering, we receive more

The ADA and the American Dental Political Action Committee (ADPAC) remain committed to ensuring that the implementation of healthcare reform does not adversely impact dentistry and the doctor patient

## DC Legislation Update

The DC Dental Society successfully lobbied the DC City Council against the Children's Oral Health Care Amendment Act of 2013. While the intent of the legislation was to enhance the oral health of DC school children, the bill would have established new categories of dental health providers to provide care without adequate training or supervision by a dentist. The DCDS joined with the DC Board of Dentistry in opposing this legislation. At the same time, our DCDS Public Policy committee is proactively working with the

DC Council's Committee on Health to present several options to improve access to care while preserving the Doctor-Patient relationship.

The Society, Foundation and DC Political Action Committee are working tirelessly to help members, provide services to at-need residents and improve oral health care literacy in our community. ## Maryland Mission of Mercy

The Maryland State Dental Association and Catholic Charities hosted their first Mission of Mercy (MOM) event in Laurel, Maryland on Aug.1-3, 2013. The event allowed over 650 patients to receive much needed dental care. Approximately 120 dentists and 362 other volunteers performed hundreds of fillings, root canals, extractions and cleanings on the very appreciative local residents.

Fifteen DC Dental Society members and staff volunteered at the three-day event which helped to make it such a huge success. One of our members, Dr. Margaret Culotta-Norton commented after the event, "This was my first Mission of Mercy and it won't be my last. There was energy present over those three days that was contagious. It was wonderful to see so many volunteers from different geographic areas and diverse socio-economic backgrounds that came

together to help those in need of dental care." The primary goal of the three-day mission was to give emergency care and in so doing help to limit visits to the Emergency Room for dental problems. Some of the non-dental volunteers were recipients of dental treatment at a previous MOM projects elsewhere and came to help to give back because they were so appreciative of the care they received. Although the Mid-Maryland MOM was able to provide over 590,000 dollars of care, there is still so much more that is needed. Dr. Culotta-Norton urges all to attend a MOM project. They are held in many states at different times of the year. It is an eye opener and well worth your time. The DCDS Foundation sincerely thanks all of our members who participated.

Over the past year, ADPAC experienced a number of legislative accomplishments and are focused on several legislative initiatives designed to support dentistry. Some of ADPAC's accomplishments and initiatives include:

- Ensuring the implementation of healthcare reform does not adversely impact dentistry.
- Amending federal legislation to exempt most dentists from being required to sign up with the Medicare program when referring Medicare patients to specialists Ensuring the implementation of healthcare reform does not adversely impact dentistry.
- Opposing 2013 federal funding for "Alternative Dental Health Care Provider Demonstration Projects."
- Fighting to reform ERISA law so patients receive the full value of their dental benefits.

- Working to pass a McCarran-Ferguson antitrust repeal amendment.
- Pushing for medical liability reform.
- Supporting House Passage of legislation to provide states with financial inducements to reform dental Medicaid programs.
- Pushing for medical liability reform.
- Fighting to increase funding for general and pediatric dental residency program, loan repayment initiatives and the CDC's Division of Oral Health.

# ADA Seeks 750 Volunteers for Mission of Mercy Event in New Orleans

**CHICAGO, Aug. 07, 2013** — Volunteers are encouraged to register for the American Dental Association (ADA) Mission of Mercy (MOM) charity dental clinic scheduled to take place Sunday, Nov. 3, in New Orleans, the site of the ADA's 2013 Annual Session and World Marketplace Exhibition. Together with America's Dentists Care Foundation and support from the Louisiana and New Orleans Dental Associations, the event aims to serve 1,000 people in need of dental care.
