Only 50 of the island's 1,200 dentists are able to work on a limited basis, due to the destruction of their offices and the limited supply of generators. Please see the article on page 11 on how you can help.

As all of you are aware, this is a licensure renewal year in the District. As a result, we've decided to offer Infection Control, a licensing requirement, at the December monthly meeting. 4 hours of infection control are required for licensure renewal. DCDS will offer two, two-hour sessions on December 5<sup>th</sup> at the Westin Georgetown. Members may take one session for two CE hours or both sessions for 4 CE hours. The afternoon session, which is from 3pm to 5pm, will cost members \$50. This nominal fees covers the Society's direct costs of offering this event. The second session, from 6pm to 8pm, will be complimentary to members. Nonmembers will be charged \$75 for each session or a total of \$150 if they attend both sessions. Please note that at this monthly meeting, we are not able to accommodate members bringing nonmembers as their guests. All non-member dentists must pay the registration fee. Please note that the December monthly meeting is a week earlier, on December 5<sup>th</sup>, due to Hanukkah.

I'd like to welcome new board member Eugenia Prokopets, who will serve the remainder of Dr. Adam Eskow's term. Dr. Prokopets is a periodontist and fourth-generation dentist. Originally from the Ukraine, she grew up in Scottsdale, Arizona. She received her DDS from Marquette University, and completed graduate training at Columbia University – New York Presbyterian Hospital, before earning her MS degree in periodontics from Louisiana State University. We're delighted to have Dr. Prokopets join us on the Board.



# **Bioterrorism and Emergency Preparedness for Dentists**

While living in Washington, DC has many perks, it also means accepting certain realities. Namely, that the District of Columbia's status as the capital of the United States makes it a larger potential target for terrorist activity than most metropolitan areas.

Following the September 11<sup>th</sup> and subsequent anthrax attacks in 2001, the Journal of the American Dental Association published an article laying out the ways that dental professionals could be called upon to act in the wake of a significant bioterrorism event. This was the first of several articles that were published in the Journal in the following years covering emergency preparedness for dentists. The thinking behind covering these topics was, and still is, that education could potentially save lives in the event of a large-scale terrorist attack.

# **Coming Soon: Your ADA/DCDS Membership Dues Renewal Notice**

Thank you for your membership in the DC Dental Society this past year! Members should receive their 2018 DCDS and ADA membership renewal notice and dues invoice in the mail later this month. At the October monthly meeting, membership voted to increase DCDS dues by \$25, to a total of \$630 for full dues.

Once you receive your 2018 invoice, you may pay your dues <u>online</u> via credit card using your ADA login credentials or mail a check (payable to the District of Columbia Dental Society) to the address on the invoice. Monthly and quarterly partial payment plans are available. Please contact the office at <u>info@dcdental.org</u> or call (202) 367-1163 to make arrangements. The membership year ends on December 31<sup>st</sup>, but members have a one-month grace period until January 31, 2018, to pay their dues. Members will still be able to attend the January Monthly Meeting during this grace period. After January 31st, there is a \$100 late fee that is added to the regular dues. When renewing, please consider making voluntary contributions to the following DCDS-related entities:

- DCDS Foundation charitable and philanthropic arm of the D.C. Dental Society that supports education, screenings and services for at-need District of Columbia residents. Donations to the Foundation are tax-deductible.
- District of Columbia Dental Political Action Committee (DCDPAC) voluntary unincorporated committee of
  individual dentists that advocates on local issues of concern to the dental profession within the District of
  Columbia.

# **Dental Assistant Registration**

According to the Dc Board of Dentistry, there are currently 1,492 registered dentists in Washington, DC, compared to just 772 total registered dental assistants. Recognizing that this number most likely does not reflect the actual number of practicing dental assistants in Washington DC, the DC Board of Dentistry is cracking down on offices using unregistered assistants. Practices found to be in violation of the Board of Dentistry's registration guidelines could be subject to a fine calculated by the number of unregistered assistants multiplied by the number of months that they have been employed.

The DCDS is encouraging all area dentists to please register any currently unregistered assistants as soon as possible, and re-register them for the upcoming period by December 31, 2017. # **Dry Mouth and Dentifrices**

#### **November Monthly Meeting**

The November DC Dental Society monthly meeting will be held Tuesday, November 14th at the Westin Georgetown and will feature a presentation by Dr. Fiona Collins entitled, "Dry Mouth and Dentifrices."



#### **Session Abstract**

Saliva fulfills many functional and protective roles in the oral cavity. This presentation briefly reviews these roles, before focusing on the etiology of dry mouth and the associated oral manifestations. An overview of current therapies available for their prevention and management is provided during the presentation, including the role of fluoride dentifrices and their ingredients, calcium and phosphate options, and other technologies that provide for the management of dry mouth.

- Describe the oral manifestations associated with dry mouth

# Infection Control is Not Optional: Dental Professionals Need to Be Involved

#### **December Monthly Meeting**

# **Did You Know? Check Your CE Report Online!**

With license renewal season fast approaching, the DCDS has begun to receive a high volume of requests for Continuing Education transcripts. We have also discovered that many members are unaware that they can track their CE and print out reports directly through our website. To do so, follow the instructions below:

- 1. Go to www.dcdental.org
- 2. Click on "Track CE" blue button on the right-hand side of the screen
- 3. Scroll down page to green "Log into CE" button
- 4. Login to the ADA CE portal. If you do not know your login information, you can reset your password by using your ADA# as your username.

You can view your CE, print out a report, and even upload CE to your own account. Hard copies of CE reports can still be provided upon request. Please allow up to 5 business days for processing.

### **Donate to Assist Dentists in Puerto Rico**

The dental community is joining together to help dentists and the public in Puerto Rico. Less than 50 of the 1,200 dentists in Puerto Rico are operating half days to serve the 3.4 million residents of the island. The information on this page provides options for those who wish to help.

The <u>ADA Foundation's Emergency Disaster Grants</u> provide up to \$2,000 in immediate financial assistance to dentists who are victims of a disaster to help with emergency personal needs such as food, clothing, shelter, bottled water, emergency lodging, and medications. Additionally, the ADA Foundation provides Emergency Disaster Grants of up to \$10,000 for 501(c)(3) organizations providing needed dental care in communities that have experienced a disaster.

Puerto Rico's dental association is also collecting monetary donations and supplies to help in Puerto Rico's recovery. Half of the funds they raise will be used to help dentists who lost their homes and practices, while the other half will be used to help provide dental care to people in need across the island. ## **New ADA Credentialing Service**

In an effort to reduce administrative burdens for all dentists, the ADA and CAQH have formed a strategic alliance to help streamline the credentialing process for dentists, dental plans and employers. The ADA® credentialing service, powered by CAQH ProView®, enables dentists to enter their professional and practice information one time in an easy-to-use, fast and protected digital platform.

Any U.S. practicing dentist can participate in this service by visiting <u>ADA.org/godigital</u> and then selecting the "My Credential" icon. By accepting the terms and conditions, the dentist will be redirected to the CAQH ProView Welcome Page. There, he or she will see certain prepopulated information from the ADA - or the information attested to previously - making it easier and quicker for the dentist to complete and attest.

Once a profile is complete and attested, dentists grant permission to the dental plans and other participating organizations they choose to access their data. The information can be used not only for credentialing, but also for provider directories, network adequacy and other business needs. A number of dental payers already participate in CAQH ProView; view the full list at <a href="CAQH.org/">CAQH.org/</a> proviewdentalplans.

Dentists can update their information any time. Automatic reminders will encourage dentists to review and attest to their information every 120 days so that profiles remain timely and accurate. The system will also prompt users if their licenses or other documentation are about to expire.
