
Welcome New Members



Materials Masterclass: Working with Lithium Disilicate and Zircona (Session 1) & Beautiful Crown Preps and Impressions Made Easy (Session 2)

September Monthly Meeting

The September DC Dental Society monthly meeting will be held Tuesday, September 10 at the Westin Georgetown and will feature two presentations by Dr. Mike DiTolla: "Monolithic Materials Masterclass: Working With Lithium Disilicate and Zircona" and "Beautiful Crown Preps and Impressions Made Easy."

Session 1—Monolithic Materials Masterclass: Working With Lithium Disilicate and Zircona

Porcelain Fused Metal (PFM) crowns now make up only 10% of the crowns fabricated by the largest dental lab in the U.S., having been largely replaced by solid zirconia and lithium disilicate. These monolithic restorations are high-strength, cementable, all-ceramic restorations behave differently than traditional restorations, and this session focuses on how to prep, adjust, de-contaminate, cement/bond, and cut off these new restorations when necessary. Perhaps most impressively, the fracture rates for these monolithic restorations are second only to cast gold.

Session 2—Beautiful Crown Preps and Impressions Made Easy

Tooth preparation with adequate reduction in the proper areas has more to do with producing esthetic anterior restorations than selecting the correct shade. Techniques will be presented to ensure that dentists give their laboratory technicians the best chance to fabricate a beautiful restoration.

E-Cigarettes and Vaping: What We Know and What We Don't

Abstract:

E-cigarette use has become an epidemic among adolescents and young adults in the United States. New information and research results are emerging on these products every day. There are many short-term health consequences related to vaping, but nothing is yet known about the longterm health effects. Oral health professionals are uniquely qualified to discuss e-cigarette use with their adult and adolescent patients. Accurate information is crucial to providing patients with evidence-based advice.

About Judith S. Gordon, PhD

Professor and Interim Associate Dean for Research, College of Nursing Professor, Family and Community Medicine, University of Arizona

Dr. Gordon received her PhD in Clinical Psychology from the University of Oregon in 1996 and completed her internship at the Portland VA Medical Center. Dr. Gordon has 25 years of experience in tobacco cessation and prevention research. She has conducted seminal research on tobacco cessation in dentistry and is currently funded on two projects aimed at reducing e-cigarette use among youth and adults. Dr. Gordon has been Principal or Co-Investigator on more than 40 projects funded by the National Institutes of Health, the Department of Defense, NASA, private foundations, and the University of Arizona. She has authored or co-authored over 120 books, products, and publications in peer-reviewed journals, and is a contributor to the upcoming Surgeon General's Report on Oral Health. Dr. Gordon has presented at numerous local, regional, national and international scientific conferences and to hundreds of healthcare professionals in clinical settings.

ADA Statement on Study in JAMA Pediatrics

JAMA Pediatrics released a study last month that examines the association between fluoride exposure during pregnancy and IQ scores of children. The study centered on mother-child pairs in Canada, with the authors concluding that higher levels of fluoride exposure during pregnancy were associated with lower IQ scores in children measured at 3-4 years old. The authors of the study note its various limitations and the fact that additional research should be conducted.

The ADA received media inquiries about the study from several national outlets; the Washington Post and USA Today already published articles. Dr. Brittany Seymour, an ADA spokesperson, was able to speak with them and provide information and perspective. <u>You can read the ADA Statement here</u>.


