## Ransomware Activity Targeting the Healthcare/Public Health Sector, Warns FBI/HHS/CISA

The Cybersecurity and Infrastructure Security Agency (CISA), Federal Bureau of Investigation (FBI), and Department of Health and Human Services (HHS) yesterday warned of an increased and imminent cyber-crime threat to U.S. hospitals and healthcare providers. HBMA has become aware of at least one member that was affected recently by a ransomware attack.

CISA, FBI, and HHS issued a joint advisor warning the Healthcare and Public Health Sector (HPH) of tactics, techniques, and procedures (TTPs) used by cybercriminals to infect systems with Ryuk ransomware for financial gain. The full report is available on the CISA website.

An understanding of the structure, function, and resulting biomechanics of natural teeth allows for maximum success in restorative dentistry. Restorative procedures with the biomimetic approach replicate the properties of natural teeth with conservative restorations that preserve intact tooth structure and pulp vitality. Traditional approaches do not even remotely restore the natural tooth properties or performance. As a result, these restorations have complications and failures that result in more aggressive and more invasive treatments over time, leading to loss of teeth. This lecture will review the major concepts and paradigm of the Biomimetic Approach.

### Medicare Annual Open Enrollment, October 15 – December 7

During Annual Medicare Open Enrollment, individuals may make many changes to their enrollment including switching between Original Medicare and Medicare Advantage, changing to a different Medicare Advantage Plan and/or updating their Prescription Drug Coverage.

## FROM THE ADA

### ADA Supports Silver Diamine Fluoride for Caries Management

The ADA has a new policy statement on the use of silver diamine fluoride for caries management.

Silver diamine fluoride, or SDF, is a topical antimicrobial and remineralizing agent. When used at 38%, it is approved by the U.S. Food and Drug Administration as a Class II medical device to treat tooth sensitivity. SDF may also be used as a non-restorative treatment to arrest carious lesions on primary and permanent teeth, which the ADA determined in its 2018 systematic review and subsequent evidence-based clinical recommendations for the arrest or reversal of noncavitated and cavitated dental caries using nonrestorative treatments in children and adults. ### ADA Supports Efforts to Allow Dentists to Administer Vaccines

The [ADA News](#) (10/23, Solana) reported the ADA House of Delegates passed a resolution on Oct. 19 that expresses the ADA's support for "dentists who are seeking to administer vaccines, including – when it becomes available – a safe and effective vaccine for COVID-19." Resolution 91H-2020 "states that dentists have the requisite knowledge and skills to administer critical vaccines that prevent life- or health-threatening conditions and protect the life and health of patients and staff at the point of care." Dr. Duc M. Ho, chair of the ADA Council on Dental Practice, said, "The pandemic has highlighted the potential benefits of an expanded role for dentists in preventive health care, including access to and the administration of vaccinations."

### CDC Revises Guidance on What Constitutes "Close Contact" with COVID-19 Cases

The [Wall Street Journal](#) (10/21, Abbott, Subscription Publication) reports the CDC has changed its definition of what constitutes close contact with a person infected with COVID-19 in the wake of a Vermont prison officer who tested positive for the disease after a number of brief interactions with infected inmates.

The [Washington Post](#) (10/21, Sun) reports the [new guidance](#) "greatly expands the pool of people considered at risk of contracting the novel coronavirus" and "is likely to have its biggest impact in schools, workplaces and other group settings where people are in contact with others for long periods of time." The CDC "had previously defined a 'close contact' as someone who spent at least 15 consecutive minutes within six feet of a confirmed coronavirus case." The updated guidance, "which health departments rely on to conduct contact tracing, now defines a close contact as someone who was within six feet of an infected individual for a total of 15 minutes or more over a 24-hour period, according to a CDC statement Wednesday."





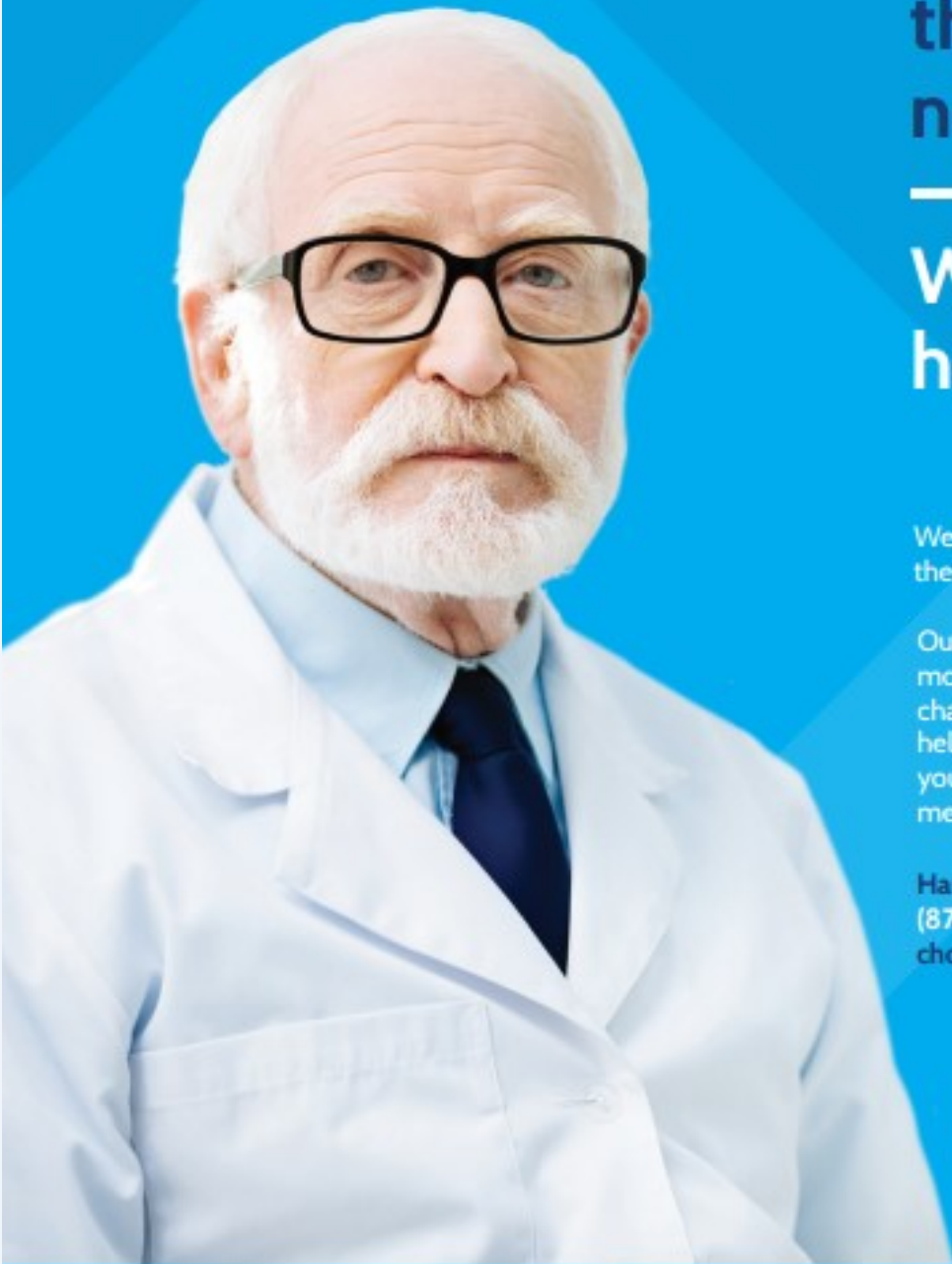
